A. Revision to Resolution 2008-7(a)

The Authority will require three (3) individual bids. Any job proposal bid which is not posted will require a bid waiver from the Board of Aldermen and the Board of Taxation.

WHEREAS, the current procedure had not been put into implementation, the Housing Authority of the City of Derby has now made this an active policy.

NOW THEREFORE, BE IT RESOLVED, that the Board of Commissioners of the Housing Authority of the City of Derby in conjunction with applicable HUD regulations, authorizes the Housing Authority of the City of Derby to accept this policy effective September 3, 2008.
